TERMS AND CONDITIONS

The Seller represents:

1. That this puppy is being sold as a pet and companion animal. This puppy is not intended for the purposes of breeding and should be spayed or neutered for the health of the animal.
2. That reasonable precautions have been taken to prevent this puppy from inheriting genetic defects of the hips, knees, eyes and heart. This puppy is warranted against these defects according to the Kennel Cuties Health Guarantee, provided at the time of delivery.
3. That this puppy has received the vaccinations and health care as represented in its written health record, which will be transferred to the Buyer at the time of delivery.

The Buyer(s) Agree(s):

1. That any deposit paid for the puppy is not refundable unless the puppy is deemed unhealthy by a licensed veterinarian prior to delivery.
2. That said dog will be given proper medical care including, but not limited to vaccinations and annual boosters, regular deworming, adequate and proper nutrition, shade and housing in a fenced yard or kennel. That the Buyer will groom, train and care for this dog in a manner consistent with high quality animal husbandry practices. All veterinarian fees and expenses shall be the responsibility of the Buyer. Under no circumstances shall **Kennel Cuties** be held responsible for any expenses for any puppy not in the possession of **Kennel Cuties**. All disputes shall be handled under the laws and jurisdiction of Arizona.
3. That this dog will **not** be used for any purposes of research or vivisection and shall **not** be sold or given to any wholesale establishment, chain store, catalog sales house, pet store or puppy mill.
4. That this dog will **never** be surrendered to any humane society, animal rescue group or animal shelter.
